#### **Context**

All schools must provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under section 78 of the Education Act 2002 and the Academies Act 2010, a PSHE curriculum:

- Promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and
- Prepares pupils at the school for the opportunities, responsibilities and experiences of later life.

#### **PSHE**

At Abbey Infant School, we teach Personal, Social, Health Education as a whole-school approach to underpin children's development as people and because we believe that this also supports their learning capacity.

The Jigsaw Programme offers us a comprehensive, carefully thought-through Scheme of Work which brings consistency and progression to our children's learning in this vital curriculum area.

The overview of the programme can be seen on the school website.

This also supports the "Personal Development" and "Behaviour and Attitude" aspects required under the Ofsted Inspection Framework, as well as significantly contributing to the school's Safeguarding and Equality Duties, the Government's British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities provided for our children.

#### **Statutory Relationships and Health Education**

"The Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019, made under sections 34 and 35 of the Children and Social Work Act 2017, make Relationships Education compulsory for all pupils receiving primary education... They also make Health Education compulsory in all schools except independent schools. Personal, Social, Health and Economic Education (PSHE) continues to be compulsory in independent schools."

Here, at Abbey Infant School we value PSHE as one way to support children’s development as human beings, to enable them to understand and respect who they are, to empower them with a voice and to equip them for life and learning.

We include the statutory Relationships and Health Education within our whole-school PSHE Programme.

To ensure progression and a spiral curriculum, we use Jigsaw, the mindful approach to PSHE, as our chosen teaching and learning programme and tailor it to your children’s needs. The mapping document: Jigsaw 3-11 and statutory Relationships and Health Education, shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements.

This programme’s complimentary update policy ensures we are always using the most up to date teaching materials and that our teachers are well-supported.

The Jigsaw Programme is aligned to the PSHE Association Programmes of Study for PSHE.

### What do we teach when and who teaches it?

#### Whole-school approach

Jigsaw covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

Term	Puzzle (Unit)	Content
<b>Autumn 1:</b>	Being Me in My World	Includes understanding my own identity and how I fit well in the class, school and global community. Jigsaw Charter established.
<b>Autumn 2:</b>	Celebrating Difference	Includes anti-bullying and understanding what different types of bullying exist and how to deal with it appropriately

<b>Spring 1:</b>	Dreams and Goals	Includes goal-setting, aspirations, who do I want to become and what would I like to do for work and to contribute to society
<b>Spring 2:</b>	Healthy Me	Includes how to keep yourself healthy and safe, healthy eating and nutrition and making good choices.
<b>Summer 1:</b>	Relationships	Includes understanding friendship, family and other relationships, conflict resolution and communication skills, bereavement and loss
<b>Summer 2:</b>	Changing Me	Includes RSE content in the context of naming and understanding the correct terminology for the male and female body parts, coping with changes and transition to prepare for moving schools or classes.

At Abbey infant School we allocate a minimum of thirty minutes to PSHE each week in order to teach the PSHE knowledge and skills in a developmental and age-appropriate way.

These explicit lessons are reinforced and enhanced in many ways:

Assemblies and collective worship, praise and reward system, our PSHE curriculum also works alongside our whole school THRIVE approach focussing on promoting pupils social and emotional wellbeing, class and school Learning Charters, through relationships child to child, adult to child and adult to adult across the school. We also still utilise the “Protective Behaviours” programme to promote discussions about how to stay safe and who can support us if we need support. We aim to ‘live’ what is learnt and apply it to everyday situations in the school community. We also regularly raise awareness of mental health and wellbeing through whole school awareness days such as “Hello Yellow Day,” “Make someone smile day” for example.

Class teachers deliver the weekly lessons to their own classes.

## Relationships Education

***What does the DfE statutory guidance on Relationships Education expect children to know by the time they leave primary school?***

Relationships Education in primary schools will cover ‘Families and people who care for me’, ‘Caring friendships’, ‘Respectful relationships’, ‘Online relationships’, and ‘Being safe’.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education. At Abbey we are an infant school and therefore only cover the content up to the end of Year 2, the 6-7 age range in the Jigsaw overviews.

It is important to explain that whilst the Relationships Puzzle (unit) in Jigsaw covers most of the statutory Relationships Education, some of the outcomes are also taught elsewhere in Jigsaw e.g. the Celebrating Difference Puzzle helps children appreciate that there are many types of family

composition and that each is important to the children involved. This holistic approach ensures the learning is reinforced through the year and across the curriculum.

Parents should also be aware that the Church of England states in “Valuing All God’s Children”, 2019, that Relationships and Sex education should: *“Make it clear that relationships and sex education is designed to prepare all pupils for the future, regardless of sexual orientation or gender identity. RSE must promote gender equality and LGBT equality and it must challenge discrimination. RSE must take the needs and experiences of LGBT people into account and it should seek to develop understanding that there are a variety of relationships and family patterns in the modern world.”* (Page 34)

## **Health Education-**

***What does the DfE statutory guidance on Health Education expect children to know by the time they leave primary school?***

Health Education in Primary schools is required to cover several aspects throughout the entirety of Primary school as we are an Infant School at Abbey we cover the Jigsaw content up to the end of Year 2, 6-7 age range and therefore learn about how to live a healthy lifestyle, understanding medicines and their important role in keeping us healthy when used safely and how to look after our mental health and wellbeing.

The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the HealthyMe Puzzle (unit) in Jigsaw covers most of the statutory Health Education, some of the outcomes are taught elsewhere in Jigsaw e.g. emotional and mental health is nurtured every lesson through the Calm me time, social skills are grown every lesson through the Connect us activity and respect is enhanced through the use of the Jigsaw Charter.

Teaching children about puberty is now a statutory requirement which sits within the Health Education part of the DfE guidance within the ‘Changing adolescent body’ strand. However, as we are an Infant school and do not have children up to Year 6 in our school, the children in Year 1 and 2 will be taught about the correct names for the male and female body parts as well as the difference between males and females (Year 2) this is to ensure children are prepared for the changes that may occur as they grow older and in order to ensure their safety by understanding the correct terms for the parts of their body. This will happen in the Summer Term as part of the Changing Me puzzle unit.

Again, the mapping document transparently shows how the Jigsaw whole-school approach spirals the learning and meets all statutory requirements and more.

## **Sex Education-**

The DfE Guidance 2019 (p.23) recommends that all primary schools ‘have a sex education programme tailored to the age and the physical and emotional maturity of the pupils.

However, ‘Sex Education is not compulsory in primary schools’. (p. 23)

Schools are to determine the content of sex education at primary school. Sex education ‘should ensure that both boys and girls are prepared for the changes that adolescence brings and –drawing

on knowledge of the human life cycle set out in the national curriculum for science - how a baby is conceived and born’.

As we are an Infant school the depth of our understanding of “Sex Education” would be for children in Year 1 and Year 2 to be able to use the correct terminology for the names of their body parts, knowing the difference between male and female body parts and understanding how to keep themselves safe. We teach this content in Summer 2 as part of the Changing me Puzzle. We also teach “Protective Behaviours” alongside Jigsaw during the Autumn Term.

### **Parents’ right to request their child be excused from Sex Education**

“Parents have the right to request that their child be withdrawn from some or all of sex education delivered as part of statutory Relationships and Sex Education” DfE Guidance p.17

At Abbey Infant School our sex education content is covered within the ‘Changing Me’ Puzzle unit of the Jigsaw programme. The depth of coverage in an Infant school would be as mentioned above; naming body parts correctly and understanding the difference between boys and girls parts. We conclude that sex education in an Infant School context refers to correctly naming female and male body parts, parents have the right to withdraw their children from the PSHE lessons that explicitly teach this. These are within the Changing Me Puzzle unit

The school will inform parents of this right by a newsletter sent home during Summer Term 1, prior to the Changing Me unit being taught.

We are of course happy to discuss the content of the curriculum and invite you to contact Mrs. Ridley should you require any further information regarding the content taught.

### **Monitoring and Review**

The Curriculum Committee of the governing body monitors this policy on an annual basis. This committee reports its findings and recommendations to the full governing body, as necessary, if the policy needs modification. The Curriculum Committee gives serious consideration to any comments from parents about the PSHE (RSHE) programme, and makes a record of all such comments. Governors scrutinise and ratify teaching materials to check they are in accordance with the school’s ethos.

### **Equality**

**This policy will inform the school’s Equalities Plan.**

At Abbey Infant School we promote respect for all and value every individual child.

We also respect the right of our children, their families and our staff, to hold beliefs, religious or otherwise, and understand that sometimes these may be in tension with our approach to some aspects of Relationships, Health and Sex Education.

## Relationships Education in Primary schools – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults.

The guidance states that, by the **end** of primary school (Year 6), PLEASE BE AWARE WE ARE AN INFANT SCHOOL AND OUR JIGSAW CONTENT GOES UP TO YEAR 2 ONLY:

## Physical health and mental well-being education in Primary schools – DfE Guidance

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:
