Statement of intent

The pupil premium grant is used to help disadvantaged pupils to make excellent progress in their learning by building solid foundations in the key areas of reading, writing and maths. At Abbey CofE Infant School, in order to utilise this additional funding in the best possible way, we have considered closely the research and advice put forward by the EEF and used timely assessments of both children's academic and personal development needs to inform our decisions. The table below outlines our intentional spend with a rationale accompanying each decision.

Challenges

1	Children enter school and nursery from lower educational start points.
2	Children have reduced access to opportunities and experiences in the home that lead to secure childhood development
3	Children have limited language and vocabulary when compared to non-disadvantaged pupils.
4	There is a greater prevalence of behavioural concerns amongst disadvantaged pupils.
5	Children's social and emotional development is lower, when compared to non-disadvantaged pupils.

Intervention Programmes: Deliver Wellcomm Sp & Lang intervention programme in EYFS. Deliver Little Wandle catch up programme.	Generally, the use of TAs to deliver high quality interventions, which complement the work of the teacher, is a 'best bet' and could be a powerful way of mitigating any impacts of time away from school and see positive gains for pupils. We suggest schools should adopt one or two well chosen, and well-implemented, TA-led interventions, judiciously used to complement and extend class-based teaching and learning. In order to support pupils who have fallen the behind furthest, structured interventions, which may also be	1,2,3,4,5

delivered one to one or in small groups, are likely to be necessary. Sessions are often brief (15-45 mins), occur regularly (e.g. 3-5 times per week) and are maintained over a sustained period of time (e.g. 8-20 weeks). Staff receive extensive training from experienced trainers or teachers.

- A greater proportion of disadvantaged pupils achieved the expected standard in the Y1 phonics screening check 2024 (91%), compared to non-disadvantaged pupils (85%)
- A greater proportion of disadvantaged pupils at Abbey CofE Infant School achieved the expected standard in the Y1 phonics screening check (91%) compared to the national percentage of 68%.

Year on year improvements are evident in our end of Key Stage assessments and school internal assessments show that children made excellent progress in reading, writing and maths when measured against their starting points. End of KS1 outcomes were above the national figures and figures for disadvantaged learners were also inline or above national.

WellComm speech and language programme delivery resulted in all children making good progress from their starting points, 90% of pupils were assessed to be at the expected standard for their age by the end of Reception. This compares to just 50% at the start of the year.

Our Thrive approach to supporting children's social and emotional development has been extremely effective in promoting positive mental health by giving them the knowledge and tools necessary to understand their feelings and behaviour. Thrive assessments show the term on term improvements.
